**A RESOLUTION DECLARING ASIAPRIME COMMODITIES CORPORATION AS THE THIRD
LOWEST CALCULATED AND RESPONSIVE BIDDER FOR PROCUREMENT OF
LEARNING RESOURCES (TELEVISION) FOR S.Y. 2023-2024**

WHEREAS, the Department of Education, General Santos City advertised the Invitation to Bid for the **Procurement of Learning Resources (Television) for S.Y. 2023-2024 Lot 1** (details in the ITB) in the PhilGEPS Website, Department of Education - Division of General Santos City's website and Bulletin Board for 7 calendar days with an Approved Budget for the Contract (ABC) of Seventeen Million (17,000,000.00);

WHEREAS, in response to the said advertisement, three (3) prospective bidders purchased bid documents in the amount of TWENTY FIVE THOUSAND PESOS (Php 25,000.00), namely Newbitech IT Solutions, M. Conpinco Home Improvement Supercenter Inc. and AsiaPrime Commodities Corp.;

WHEREAS, in the Resolutions 2023-004-L1 and 2023-004-L1-A both for Newbitech IT Solutions and M. Conpinco Home Improvement Supercenter Inc., respectively, the BAC declared the bidders as the lowest and the 2nd lowest Calculated Bidders;

WHEREAS, in the post qualification conducted separately to both bidders, the BAC declared the bidders post disqualified;

WHEREAS, AsiaPrime Commodities Corp obtained the next-ranked Calculated Bid, thus a corresponding post qualification was conducted by the BAC-TWG on May 31, 2023;

WHEREAS, upon BAC-TWG's verification and evaluation, it was found out that AsiaPrime Commodities Corp's bid was responsive, thus considered as the third lowest calculated and responsive bidder;

WHEREAS, the BAC finds the recommendation of the TWG/End-User in accordance with RA 9184 and its 2016 Revised IRR;

NOW THEREFORE, for and in consideration of the foregoing, We the Members of the Bids and Awards Committee (BAC), hereby RECOMMENDS to the Head of the Procuring Entity (HOPE), the following:

- a) To declare AsiaPrime Commodities Corp post-qualified for Project No. 2023 – 004- Lot 1 for the Procurement of Learning Resources (Television) for S.Y. 2023-2024) with a bid amount of Fifteen Million Four Hundred Eighty Thousand and 25/00 (15,480,000.25)
- b) To seek approval of the findings from HOPE and to issue NOA.
