WHEREAS, the Department of Education, General Santos City advertised the Invitation to Bid for the Procurement of Fruit Juice for 13,806 SBFP Beneficiaries in the PhilGEPS Website, Department of Education - Division of General Santos City Bulletin Board and website for 7 calendar days;

WHEREAS, in response to the said advertisement, a lone bidder namely TSM Food Products purchased bid documents in the amount of FIVE THOUSAND PESOS (Php 5,000.00) for the project;






